ARE YOU INTERESTED IN SEEKING ADDITIONAL CERTIFICATION?

If you are currently licensed in one of the primary disciplines (Radiography, Nuclear Medicine, or Radiation Therapy) and have an interest in post-primary certification, there are considerations to keep in mind.

1. You may need a Provisional Training License.

- If you are a licensed Nuclear Medicine Technologist or Radiation Therapist seeking post-primary certification in Computed Tomography (CT), you shall hold a Provisional CT Training License.
- If you are a licensed Radiographer or Radiation Therapist seeking post-primary certification in Positron Emission Tomography (PET), you shall hold a Provisional PET Training License.

2. You may apply for a MIRT Scholarship.

- The Scholarship Fund was established for both entry level education and for those seeking advanced education in medical imaging and radiation therapy.
- Recipients of the Scholarship receive up to \$1,500 annually. See additional information on page 2.

PROVISIONAL TRAINING LICENSE INFO

The Provisional CT Training License and the Provisional PET Training License, is required by [201 KAR 46:050](#). The process for applying includes submitting the appropriate application along with the required fee of fifty (50) dollars. Once issued, the training license is active for a period of twenty four (24) months and can be renewed once.

Provisional CT Training License:

- Submit [Application](#); and
- \$50 Fee
- May work under the direct supervision of a licensed and certified CT technologist to gain clinical competency

Provisional PET Training License:

- Submit [Application](#); and
- \$50 Fee
- May work under the direct supervision of a licensed and certified PET technologist with the permission of an authorized user to gain clinical competency

REMINDERS

- License renewal is completed annually during licensee's birth month
- Online renewal window opens on the first of the month prior to the month you are due for renewal and closes on the last day of the month
- Licensees do not submit CE certificates to the Board unless requested through an audit
- All licensees, except LXMOs, must maintain active status with ARRT or NMTCB
- Individuals CANNOT practice without a valid license

2023 SCHOLARSHIP APPLICATION NOW OPEN

The Kentucky Medical Imaging and Radiation Therapy Scholarship and Continuing Education Fund was established in accordance with KRS 311B.050 for individuals seeking entry level or advanced education in the medical imaging and radiation therapy professions and for individuals seeking non-degree education, such as structured education or limited x-ray machine operator programs. [201 KAR 46:100](#) establishes requirements relating to the scholarship program. The scholarship is for both entry level and current licensees seeking further education in the profession, such as post-primary certification.

Applications are accepted between January 1 and April 1 annually; the postmarked date will be used to determine submission date. Applications postmarked after April 1 will not be considered. In addition to the application form, eligibility requires the applicant to submit a current resume or curriculum vitae, three letters of recommendation, official transcripts from highest level of education achieved, and a written statement describing the applicant's professional goals. Recipients receive a scholarship award not to exceed \$1,500 annually.
